ORDER VI

Chicken Farmers of New Brunswick Service Charge

- 1) A charge for service is hereby fixed at 1.20 cent (plus HST) per kilogram live weight of chicken meat, which shall be paid to the Board by the producer for chicken delivered by the producer to a processor.
- 2) The charge shall be due and payable to the Board on delivery by the producer to the processor of the chicken.
- (3) Every processor is hereby required to collect such service charge on behalf of the Board from the producer on delivery of the chicken and to remit the amount so collected to the Board no later than the Monday following the delivery.
- 2) 1) A charge for services is hereby fixed at 1.20 cent (plus HST) per kilogram live weight of chicken meat, which shall be paid to the Board by the producer for chicken processed for marketing by a producer who processes the chicken produced by him.
- 2) The charge for service must be received by the Board from the processor no later than 15 days after the last day of the month in which the chicken were delivered to the processor. All amounts outstanding shall bear interest at 2% per month.

4. A processor who accepts chicken from a producer and does not collect the service charge from the producer at the time of delivery shall pay a charge for services equal to 1.20 cent (plus HST) per kilogram live weight for the chicken so accepted.
5. Every processor shall, with the remittance of the service charge, furnish the Board with information as to the producer, names, dates, number of chicken, weight of chicken and such other information relating to the production, packing, transporting and marketing of chicken as the Board may request on the information form supplied by the Board.
6. 1) A charge for service is hereby fixed at 44 cents per kilogram live weight of chicken marketed by a producer in excess of 102% but less than 104% of his or her allocation.

2) A charge for service is hereby fixed at 88 cents per kilogram of live weight of chicken marketed by a producer in excess of 104% of his or her allocation.
7. Where a producer has been assessed a charge for service pursuant to section 6; the amount is immediately due and payable to the Board and shall be paid forthwith.
8. This Order comes into force January 16, 2022.
