The New Brunswick Health Council is undergoing a significant change in its mandate as the Legislative Assembly approved *An Act to Amend the New Brunswick Health Council Act* in December 2022. These amendments will change the New Brunswick Health Council to the New Brunswick Health and Senior Care Council and allow it to become the data hub for health and long-term care data in New Brunswick. This will facilitate evidence-based policy and decision-making.
